

## Contest Details

- Contest period will be from 9:00 am on August 5 to 23:59 pm September 25, 2023.
- Only NRI's in UK and residents of United Kingdom can participate in this contest
- Entries received outside the contest period will not be considered
- By registering, the participant agrees to be bound by these Terms and Conditions
- Participants can fill the Registration Form online through our website or from ICICI Bank UK PLC Branch by scanning QR code on collaterals to register online.
- Participants will be provided Crayons & Drawing Sheet from ICICI Bank UK PLC Branch subject to verifying their details as per the registration form. Also, participants can use their own materials to create the drawing and submit in the branch.
- Participants can draw based on two themes:
  - Yeh Mera India
  - Go Green
- Participation and Submission of the artwork will take place at the ICICI Bank UK Branch only. Participants have to collect and submit their artwork at the same branch.
- An Independent Judge will be selected by ICICI Bank UK to select winners from this contest and their decision shall be final.
